

The wall was publicly presented as a protective measure for Roma children. In reality, official statements revealed that its purpose was to "protect other citizens" from the Roma community.




# CRAICA

# PUBLIC MEETINGS

In 2011, during a public meeting, the mayor requested that the railway director prevent Roma people from arriving in Baia Mare by train. In 2012, I witnessed Mayor Cătălin Cherecheș presenting non-existent housing solutions for the Roma community of Craica.




# CRAICA

In 2012, I was mandated by Amnesty International to document the announced forced evictions in Craica. Throughout that year, I repeatedly returned to Baia Mare and intervened each time the authorities attempted to carry out the demolitions, effectively preventing the eviction of the community.








# CUPROM

In 2012, after the forced relocation of Roma families from Craica to the former Cuprom facility, I witnessed serious health incidents affecting residents housed there. Several families, who had initially accepted the relocation, returned to Craica after experiencing these conditions.






# CONTRACTS

Following the relocation, the initial housing contracts signed by Roma residents were withdrawn and replaced with new contracts containing significantly harsher terms.

# PENAL CASE

Roma residents were encouraged to place their trust in Romani Criss and to constitute themselves as injured parties in a criminal complaint against the municipality regarding the conditions at Cuprom.

- The representatives of Romani Criss stopped responding to phone calls from Roma community members.
- Without legal or institutional support, and under sustained pressure from the mayor and local authorities, the affected Roma families eventually withdrew their criminal complaint.



# PROJECTION NIGHT

In 2012, I presented the situation of the Roma community from Baia Mare at the Visa pour l'Image international photojournalism festival in Perpignan, France, during a dedicated professional program.



In Ferneziu, I continued documenting the daily living conditions of Roma families.






# EU PARLIAMENT




# BBC MOVIE

# SURVIVOR

A few days later, my attention was drawn to a young girl using a walking aid.

Several hours later, her mother informed me that Denisa had fallen from the fourth floor while playing with other children, due to the absence of a safety railing on the balcony. She survived the fall miraculously.






In 2014, I addressed an open letter to students of the University of Arts in Cluj, after they were misled by the mayor of Baia Mare into vandalizing the segregation wall under the pretext of turning it into an artistic intervention.



# AD INSULT TO INJURY

In a public statement, Mayor Cătălin Cherecheș referred to the segregation wall using dehumanizing metaphors, further reinforcing the discriminatory narrative surrounding the Roma community.

# OPEN LETTER TO THE PRESIDENT OF ROMANIA

- In January 2015, I addressed an open letter to the President of Romania regarding the situation of the Roma community in Baia Mare and the existence of the segregation wall.

Domnule Președinte,

În anul 2011 am ajuns pentru prima dată în Baia Mare. Inițiativa primarului Cătălin Cherecheș de a ridica un zid de beton în jurul unei comunități de romi mi-a atras atenția și m-a determinat să mă deplasez la fața locului pentru a vedea cu ochii mei această monstruozitate. Fotografiile realizate de mine au fost folosite în procesul intentat de CNCD primăriei din Baia Mare. La sfârșitul anului 2013, Curtea Supremă, printr-o sentință definitivă și irevocabilă, a declarat zidul un act de segregare.

Am vorbit atunci cu președintele CNCD, domnul Csaba Asztalos, și l-am întrebat dacă pot cere eu, în nume propriu, demolarea zidului. Mi-a răspuns că nu pot face acest lucru ca persoană fizică, aşa că am încercat să îmi înființez o fundație. Costul prea mare al capitalului social m-a împiedicat însă să îmi duc planul până la capăt.

Deși am adresat o scrisoare deschisă tuturor ONG-urilor rome și nu numai, cerându-le să deschidă un nou proces, plecând de la hotărârea definitivă, și să ceară demolarea zidului, din diverse motive, pe care vă las să le intuiți, nimici nu a mișcat un deget nici până azi.

Timp de 3 ani am documentat suferințele romilor din acel oraș, cazul zidului nefiind, din păcate, unul izolat.

Am văzut că ați răspuns pozitiv campaniei de PR a Simonei Halep atunci când v-a invitat să cântați imnul alături de ea. Deși nu sunt un sportiv, pot spera la același răspuns din partea președintelui meu atunci când vă invit să cereți în mod public dărâmarea zidului din Baia Mare?

Vă mulțumesc și sper că acest text va fi înscris în cartea de onoare a celor mai demne perioade din istoria României.

JANUARY 2015

In January 2015, I was invited to the Presidential Palace (Cotroceni) by the President of Romania. On that occasion, I handed over a photographic album and an open letter detailing the situation of the Roma community in Baia Mare.

Together with the magazine GEO and Edition Lammerhuber, UNICEF Germany presented the book at Frankfurt Book Fair, a documentation of which you will find enclosed. „It is a volume that cannot soothe and offers comfort in only a few pictures. It rather reveals the to-do-list of international politics and of many specific countries and societies in the anniversary year of the Convention on the Rights of the Child – everything that has remained paper and not become a reality yet“, writes editor Peter-Matthias Gaede in the preamble.







# 2018

In 2018, after repeated eviction attempts had failed, the local authorities adopted new measures aimed at forcing Roma families to leave their settlements.

# EVACUATION BY HUNGER

- A City Council decision abruptly prohibited the raising of livestock throughout Baia Mare, with explicit exceptions granted to non-Roma neighborhoods.
- As a result, Roma communities in Craica and Pirită were deprived of their primary means of subsistence.
- This measure effectively amounted to eviction through economic deprivation.



2021

In 2020, legal proceedings were initiated to obtain the demolition of the segregation wall. In 2021, the first court hearing took place at the Baia Mare Court, together with the association's legal counsel.



# ARRESTED

At the end of 2023, the former mayor received a final prison sentence of five years. He subsequently attempted to evade justice by fleeing the country, but was apprehended by law enforcement authorities in Germany.

# INVITATION

- I invite Roma communities and Roma civil society organizations to:
  - formally request the Municipality of Baia Mare to comply, without delay, with the final court ruling ordering the demolition of the segregation wall;
  - request transparent information regarding the timeline for the implementation of the works;
  - be present in Baia Mare at the moment the wall is finally dismantled.
- I dedicate this legal victory to all Roma people in Romania and beyond. It stands as proof that, through perseverance, solidarity, and integrity, systemic injustice can be challenged and overcome.
- Let us tear down this wall together.



# CONTEXT AND PERSONAL CONSEQUENCES

- As a result of this work, I have been subjected to repeated intimidation and harassment, including the vandalization of my car in 2012. I was publicly labeled by the mayor of Baia Mare as “Public Enemy No. 1”.
- Despite this, the situation in Baia Mare has been documented and presented internationally through major media productions and exhibitions, including the BBC documentary “Living with the Roma”, exhibitions at the European Parliament, and international photojournalism festivals.

# I HAVE MANY REASONS...

- While working on an Amnesty International country report, I once entered a shack in Craica late in the evening, drawn by a light. There was no electricity. The family was working by flashlight. A man who had previously told me that everything he owned came from the garbage dump was carefully assembling an old picture frame. Inside it, he had arranged photographs I had given him a year earlier.
- This is why I do this work.

■ Message to the President of Romania, Nicușor Dan

**Dear Mr. President,**

**After 14 years of sustained civic engagement, professional work, and personal dedication, I have obtained a final court ruling ordering the demolition of the ethnic segregation wall in Baia Mare — a structure that violates not only constitutional principles, but also fundamental norms of human dignity and equality.**

**This initiative was carried out entirely outside institutional frameworks, without public funding and without political backing, driven solely by the conviction that Romania can and must acknowledge and correct the injustices of its recent past.**

**With the legal process now concluded, the remaining and essential step is the effective enforcement of the ruling. The demolition of the wall requires administrative coordination and public resources, and it would be both unreasonable and unjust for a private citizen to assume financial responsibility for an obligation that rests, legally and morally, with the Romanian state.**

**As the President of Romania, I respectfully request that you instruct the competent institutional authorities to take the necessary measures to enforce the final court decision and proceed with the demolition of the wall.**

**Beyond its material existence, this wall remains a powerful symbol of institutional failure and ethnic segregation. Its removal would represent not only the execution of a legal obligation, but also a clear signal that the rule of law, accountability, and respect for human dignity are once again guiding principles of the Romanian state.**

**For your reference, I am attaching a detailed documentary presentation outlining the history of the case, the long-standing institutional inaction, and the legal process that led to the final ruling.**
